Each of the Pools will be available to residents registered into and shown to be in "good standing" in the Database System, on a first-come first-served, reservation-only basis, for private parties during the summer swim season only (from the last day of school in May and/or June to the first day of school in August), subject to (a) the availability of lifeguards through the District's pool management contractor, Lifeguard 4 Hire; and (b) the terms of the Pool Rules and Regulations. Private parties will be limited to a maximum of 50 guests and may only be scheduled between the hours of 8:00 p.m. and 10:00 p.m. on a Friday, Saturday or Sunday. All private parties must end and all participants depart the facility by 10:00 p.m. Any guests who are not registered into the Database System must execute an Application to Use Recreational Facilities and Release of Liability. If a guest is under the age of 18, the Application and Release must be signed by their parent or legal guardian.

The host of any private party must contract with and pay a \$100 fee to Lifeguard 4 Hire. Reservations must be scheduled with Lifeguard 4 Hire at least 14 days in advance, and will be subject to availability of lifeguards and the availability of the facility. In addition, a \$100 facilities use and clean-up deposit, payable to Block House MUD, is required. Reservations are ONLY confirmed upon receipt of FULL PAYMENT. Cancellations may be made up to 3 days before the party date and will receive a refund minus a \$25 service charge. Full refund will be issued if cancellation is made at least two weeks prior to party date. In the event of inclement weather during the scheduled hours of the party, a refund will be given based on hours of use. Alcoholic beverages and illegal or controlled substances are not permitted at any time. A violation of this policy during a private party may result in permanent suspension of pool privileges. The District's rules will be enforced during all private parties, and violation of the rules may result in immediate cancellation of the party and close of the pool, without refund of any fees paid.
